1. Public Hearing – Parviz Farahzav, 101 Winner's Circle for Conditional Use

Each complainant shall file with the Village Clerk on or before February 19, 2019 a statement under oath, specifying the respect in which the assessment complained of is incorrect, which statement must be made by the person whose property is assessed or by some person authorized to make such statement who has the knowledge of the facts stated therein.

# C. <u>Village Election</u>

1. On motion of Trustee Cohen, seconded by Trustee Malatino, it was unanimously

RESOLVED that the Village Clerk be and hereby is directed to publish in the official newspaper of the Village at least ten days prior to the General Village Election to be held on Tuesday, March 19, 2019 a notice that shall state:

- The polling place in each election district;
- The hours during which the polls shall be open, to wit, from noon to nine o'clock in the evening;
- The names and addresses of those who have been duly nominated in accordance with the provisions of the election law for the Village office whose petitions have been duly filed with

the Village Clerk, and the offices and terms of said office for which they have been so nominated.

2. On motion of Trustee Scheff, seconded by Trustee Cohen, the following resolution was unanimously adopted:

WHEREAS, the Village Clerk, as election officer of the Village of Port Washington North, has attempted to obtain the names of six residents of the Village of Port Washington North who would qualify to hold the office of Inspector of Election, in accordance with the election Law of the State of New York; and

WHEREAS, the Village Clerk has not been able to find six persons who reside within the Village of Port Washington North who reside within the Village of Port Washington North and who meet the requirements to be appointed as Inspectors of Election as specified in the Election Law and who are willing to serve as such;

RESOLVED that Maria D'Urso, Judith Epstein, Theodore Knopp and Margaret Malanga be and hereby are appointed Inspectors of Election for the next General Village Election, that Janet Knopp and Stanley Strauss be and hereby are appointed Alternate Inspectors of Election, and that said Margaret Malanga be and hereby is appointed Chairperson of said Inspectors; and

BE IT FURTHER RESOLVED that said Inspectors and Alternate Inspectors, except for the Chairperson, shall be compensated at the rate of \$175.00 per day and that said Chairperson shall be compensated at the rate of \$200.00 per day; and

BE FURTHER RESOLVED that the Inspectors of Election of the Village of Port Washington North shall prepare the Register of Voters for the General 2019 Election of the Village of Port Washington North on Thursday, March 14, 2019 at the Village Hall, 3 Pleasant Avenue, Port Washington, New York, commencing at 9:00 a.m.

This contract is for a term ending April 2019, except that either party may terminate the agreement at any time.

#### B. <u>Village Hall Cleaning Contract</u>

On motion of Trustee Scheff, seconded by Trustee Cohen, it was unanimously RESOLVED that the Village of Port Washington North will continue the contract with Capital Contractors Inc., 88 Duryea Road, Melville, New York, to provide janitorial cleaning services at the Village Hall, 3 Pleasant Avenue, amending, however, the monthly fee to \$338.38.

# D. <u>Site Plan Review – TJ Maxx, 1 Soundview Marketplace</u>

Max Rinaldi of Soundview Marketplace and Robert Eschbacher of VHB addressed the Board of Trustees with respect to the Site Plan Review application of Rosenbaum Design Group for a proposed TJMaxx parking lot and traffic plan for Soundview Marketplace, Shore Road, Port Washington, New York. On motion of Trustee Malatino, seconded by Trustee Cohen, the following resolution was unanimously adopted:

WHEREAS, the Board of Trustees of the Village of Port Washington North held a public hearing on June 20, 2018 with respect to the Site Plan Review application of Rosenbaum Design Group on behalf of TJMaxx and LBUBS 2007-C7 Shore Road, LLC., as owner of the premises located at 1 Soundview Marketplace, Shore Road, Port Washington, New York (premises designated on the Nassau County Land & Tax Map as Section 4, Block 129, Lots 1, 10, 12 & 14C), and all people present were heard or were given an opportunity to be heard; and

WHEREAS, the Board of Trustees has determined that the application is subject to site plan review pursuant to Chapter 137 of the Port Washington North Village Code; and

WHEREAS, the Board of Trustees established itself as lead agency and has determined that the action constitutes a type II action pursuant to Section 617.2 of the SEQRA Regulations and has further determined that the action will not result in any significant adverse impacts on the environment; and

WHEREAS, the Board of Trustees has reviewed the application and the "Pedestrian Safety Improvements" parking lot and traffic plan, prepared by VHB on behalf of TJMaxx and bearing the latest revision date of June 29, 2018, and has carefully considered the testimony and all other relevant evidence presented at the public hearing held on June 20, 2018; now, therefore, be it

RESOLVED that the Board of Trustees, after site plan review pursuant to the Code of the Village of Port Washington North, hereby approves the "Pedestrian Safety Improvements" parking lot and traffic plan, bearing the latest revision date of June 29, 2018, prepared by VHB on behalf of TJMaxx and LBUBS 2007-C7 Shore Road LLC, as owner of the premises located at 1 Soundview Marketplace, Shore Road, Port Washington, New York (premises designated on the Nassau County Land & Tax Map as Section 4, Block 129, Lots 1, 10, 12 & 14C), as submitted to the Village of Port Washington North, subject to any diminimous changes the Village Superintendent of Buildings may deem necessary for the safety of the public.
