

The PORT WASHINGTON GARBAGE DISTRICT has arranged for the collection of garbage, recyclables and yard waste for the year 2020 with Dejana Industries LLC. Pay special attention to the **RECYCLING COLLECTION SCHEDULE** as well as the **HOLIDAY SCHEDULE** and the **YARD WASTE COLLECTION SCHEDULES. SCHEDULES MAY HAVE CHANGED.**

* * REGULATIONS * *

ACCEPTABLE WASTE (GARBAGE):

PLACED OUT BY 7:00 A.M. A. RESIDENTIAL PROPERTIES: Waste generated from the normal day to day operations of the household and kitchen. WASTE: This includes all food waste, fish, meats and vegetables, paper packages, etc. Garbage is collected three times a week. Collections will be made on Monday, Wednesday and Friday in one part of the district and Tuesday, Thursday and Saturday in the other part of the district. See map on reverse side. Garbage shall be stored in closed leak proof metallic or plastic containers and placed in the curb. No collection will be made inside the house or garage. Garbage is to be collected from one location only. A maximum of three (3), thirty-two (32) gallon cans (or equivalent bags) none weighing more than 50 lbs. will be collected each day,

RUBBISH:
PLACED OUT
BY 7:00 A.M.

Waste generated from the household other than kitchen waste, yard waste and recyclables. Rubbish could include materials from the clean up of a closet, garage or attic and other similar items. Rubbish will be collected from the **CURB** on the same day as your regular garbage collection. Rubbish should be stored in closed containers or tied when possible. One (1), thirty-two (32) gallon can or the equivalent, weighing no more than fifty (50) pounds per can of rubbish will be collected. **Contractor Material Will Not Be Collected. Check website for C & D guidlines.**

MANDATORY CURBSIDE RECYCLING:

PLACED OUT BY 7:00 A.M. The Town of North Hempstead has a mandatory recycling program for paper, bottles and cans, newspaper, junk mail, phone books, catalogs, magazines, construction paper, cards, paperback books, non-metallic wrapping papers, corrugated cardboard are to be recycled. Tie and bundle these materials and place at curb for collection. Rinsed/Clean bottles, cans, aluminum foil containers, pie tins, plastic bottles (#1 & 2 only) and containers, etc. should be placed in the recycling container at the curb for collection. Please see reverse side for your Recycling schedule.

YARD WASTE: PLACED OUT BY 7:00 A.M.

Includes grass, leaves, hedge clippings and tree limbs. Hedge clippings and tree limbs no larger than 2 inches in diameter. Must be tied securely into bundles no larger than 2 feet wide by 3 feet in length. Grass and leaves must be placed in Lawn & Leaf Bags (we recommend paper bags) or placed in a marked yard waste receptacle up to 32 gallon in size. Bundles, bags or cans should not weigh more than fifty (50) pounds. All contained yard waste should be placed at the curb separate from your regular garbage. If your regular garbage collection day is Monday/Wednesday/Friday, your yard waste will be collected on Monday. If your regular collection day is Tuesday/Thursday/Saturday, your yard waste will be collected on Tuesday. Collection begins on the first week of April and continues until the second week of December. Christmas trees will be picked up during the first two weeks of January. LANDSCAPERS ARE REQUIRED BY LAW TO REMOVE ANY YARD WASTE CREATED AS THE RESULT OF THEIR COMMERCIAL ACTIVITY.

BULK ITEMS /
"WHITE GOODS":

Includes furniture, mattresses, box springs, rugs and appliances ("White Goods" such as refrigerators, hot water heaters, washers, dryers, etc.) are considered bulk items. **One (1)** of these items will be collected per week from the curb on your last regular pick up day of the week. Doors must be removed from Refrigerators and Freezers. Rugs should be tied and cut in four (4) feet lengths (ONLY picked up on Friday and Saturday along with One (1) can of C & D homeowner generated). Only four rolls of carpet per week. Please contact Dejana Industries LLC to confirm pick-up for all items.

Hazardous waste, volatile materials, propane tanks, gas tanks, bricks, asphalt, concrete, granite, marble, toilets, stone and stoneware, lime, asbestos, automobile parts (engines, transmissions, rear ends, auto body parts, etc.), pipes, paint cans with liquid, infectious and/or biological waste, logs or wood longer than 3' feet and larger than 2" in diameter, chain link fencing and cables, scrap lumber and other debris resulting from the construction or renovation of premises by Contractors.
