On motion of Trustee Malatino, seconded by Trustee Cohen, it was unanimously RESOLVED that the Village Clerk is hereby directed to solicit three written price quotes, pursuant to the Village Procurement Policy for public works contracts, for the Street Light Maintenance 2024/2025 contract.

# C. <u>Snow Plowing, Sanding & Salting 2024/25 Contract Extension</u>

On motion of Trustee Malatino, seconded by Trustee Cohen, it was unanimously RESOLVED that the Village of Port Washington North hereby exercises its option to extend the Snow Plowing, Sanding and Salting contract with Creative Snow by Cow Bay, for the period September 1, 2024 through August 31, 2025, upon the terms, conditions and prices set forth in the bid proposal and contract received August 14, 2023.

#### D. Leaf Removal Contract Renewal

On motion of Trustee Malatino, seconded by Trustee Cohen, it was unanimously RESOLVED that the Village is hereby exercising its option to extend the contract for the Removal of Leaves for Fall 2024 with Dom's Lawnmaker Inc., at the cost of \$29,680.00, in accordance with the terms of the bid document dated September 5, 2022.

## E. <u>Stormwater Management Program Plan July 2024 – H 2 M</u>

Mayor Weitzner announced that the final Stormwater Management Program Plan July 2024 for the Village of Port Washington North, developed by H 2 M to comply with the new regulations set forth by the New York State Department of Conservation for Stormwater Discharges from Municipal Separate Storm Sewer Systems. The SWMP Plan was posted on the Village's website on July 8, 2024 and is

available at the Village Hall. On motion of Trustee Cohen, seconded by Trustee Malatino, it was unanimously

RESOLVED that the final Stormwater Management Program Plan July 2024 for the Village of Port Washington North prepared by H2M is hereby approved.

## F. Stormwater Outfall Inspections - H 2 M

On motion of Trustee Malatino, seconded by Trustee Cohen, it was unanimously RESOLVED that the Village of Port Washington North hereby engages H 2 M Architects & Engineers to conduct storm sewer outfall reconnaissance and to prepare an inventory for each outfall, in accordance with its written proposal dated June 24, 2024, at a cost not to exceed \$4,800.00.

# G. Accessible Recreational Facility Phase 2 Playground Design – H 2 M

On motion of Trustee Cohen, seconded by Trustee Malatino, it was unanimously RESOLVED that the Village of Port Washington North hereby engages H 2 M Architects & Engineers for professional engineering services relative to the Accessible Recreational Facility Phase 2 Playground Design Development, in accordance with the terms and conditions set forth in its written proposal dated July 3, 2024, at a cost not to exceed \$16,000.00.

## H. Avaya Cloud/Ring Central Phone System Renewal

## I. Bay Walk Park Turf Replacement – Synthetic Grass

On motion of Trustee Cohen, seconded by Trustee Malatino, it was unanimously RESOLVED that the Village hereby authorizes the performance of extra work under the Park Maintenance contract to resolve an ongoing problem in an approximately 15-foot by 15-foot portion of Bay Walk Park, to wit, Demelas & Sons Landscape Contractors Inc. to procure and install synthetic grass by ForeverLawn, in accordance with its proposal dated 6/20/2024, at a cost not to exceed \$8,300.00.
