## Utility Pole Removal by Diwan

The damaged utility pole on Shore Road, across from Diwan, has finally been removed. Thanks to the persistent efforts of Village staff and officials, Verizon arrived on March 4th to take down the unsightly pole.

We understand the concerns this damaged pole raised and want to assure residents that the Village initiated the removal process promptly after the incident occurred in September 2024.

Why did it take so long? Each utility with wires on the damaged pole had to be notified and required to transfer their lines to the newly installed pole—starting from the lowest set of wires to the highest. In this case, five separate utilities shared the pole, and each had to complete their transfer before the next could proceed. Verizon, as the final utility and owner of the damaged pole, was only able to remove it after all other lines had been relocated. Once this process was completed, Verizon moved its wires on March 4th and removed the old pole.

We appreciate the patience and understanding of our Village residents throughout this process.

## Water Main Project Update

The Port Washington Water District has allocated funds to replace several water mains throughout our village. Phase 1 of the project, which involved installing the water mains, was completed in January. We are pleased to announce that Phase 2, connecting each home directly to the new water main, has also been completed.

The next phase will involve the contractor milling and filling the sections of roads affected by the construction with a base coat.

Once all work is complete, the Village will repave all Village owned roads curb to curb that were impacted by the water main replacement. Cow Neck Road is a Nassau County road and the responsibility for repairs will be conducted through the Port Washington Water District with oversight from Nassau County DPW.

We sincerely thank the residents affected by this project for their patience and understanding. The outcome will be a new water main that provides reliable service to those impacted.

## Shore Road Lane Closure Update

As part of the Nassau County DPW General Requirements Contract, Pratt Brothers Construction returned to Shore Road in Port Washington North to address a washed-out section of the roadway. Work was scheduled to begin on Monday, February 17, 2025 and it was completed on February 26th. We are pleased to announce the closed lane is now re-opened! We wanted to thank our Nassau County Legislator Delia DeRiggi-Whitton for spearheading the project and special thanks to Nassau County DPW for getting the project completed.

We appreciate the community's patience and cooperation as we work to improve the safety and stability of Shore Road.
